



REGERING VAN CURAÇAO

ANNOUNCEMENT

Through this publication, the Government of the Country of Curaçao announces that the retail prices for the products Mogas 95, Gas Oil LSD, LPG 100 lbs and LPG 20 lbs, shall be adjusted as per 2 April 2013.

Considering the frequent fluctuations of international oil prices, the government feels obliged, whenever necessary, to provide the following:

1. the monthly adjustment of the retail prices; and
2. the publication of the current and new end user rates per product.

From 4 March 2013 to 1 April 2013, the price breakdown for Mogas 95, Gas Oil LSD, LPG 100 lbs and LPG 20 lbs shall be as follows:
