

NOTIFICATION

Through this publication, the Government of the Country of Curaçao announces that the retail prices for the products Mogas 95, Gasoil LSD, LPG 100 lbs and LPG 20 lbs, shall be adjusted as per 3 February 2015.

In view of the frequent fluctuations in the international oil prices, the government feels obliged to proceed to:

1. the monthly adjustment of the retail prices, and;
2. the publication of the current and new end user rates per product.

From to 30 December 2014 to 2 February 2015, the price breakdown for Mogas 95, Gasoil LSD, LPG 100 lbs and LPG 20 lbs, shall be as follows:
