## **Explanation**

The decision was made to maintain electricity- and water tariffs for May at consistent levels compared to those of April. Measures taken in relation to the COVID-19 pandemic have caused severe declines in electricity- and water sales volumes. The electricity- and water producer / distributer will have to take measures to guarantee the supply of these products in Curaçao, but besides this it remains crucial that the regulated tariffs also contribute to safeguard this supply. Benefits resulting from declining fuel prices will be used to maintain electricity prices, which declines are however relatively low as existing fuel stocks will have to be used first. Noteworthy is that prices for the month of May should have increased as a result of a correction for the production-mixes relating to March, but these increases will be included in upcoming monthly calculations.
