



Through this publication, the Government of Curaçao announces that the end user price for the products Mogas 95 and Gasoil LSD shall be adjusted as per 2 August 2022. The end user prices for the products LPG 100 lbs and LPG 20 lbs remain unchanged.

In view of the frequent fluctuations in the international oil prices, the government feels obliged to proceed to:

1. the monthly adjustment of the end user prices, and
2. the publication of the current and new end user prices per product.

From 28 June 2022 through 1 August 2022, the price breakdown for Mogas 95, Gasoil LSD, LPG 100 lbs and LPG 20 lbs, is as follows:

Explanation

The end-user tariff for Mogas 95 increases slightly as a result of a significant decrease in the purchase price in combination with a significant increase in the surplus/deficit component. The surplus/deficit component is increasing significantly as the deficits in the surplus/deficit component caused by the price mitigation measures applied in prior months are now partly being corrected. The retail price for LSD increases as a result of an increase in the purchase price.
