



Through this publication, the Government of Curaçao announces that the end user price for the products Mogas 95 and Gasoil LSD shall be adjusted as per the 26th of September 2023. The end user prices for the products LPG 100 lbs and LPG 20 lbs remains unchanged.

In view of the frequent fluctuations in the international oil prices, the government feels obliged to proceed to:

1. the monthly adjustment of the end user prices, and
2. the publication of the current and new end user prices per product.

From the 29th of August 2023 through the 25th of September 2023, the price breakdown for Mogas 95, Gasoil LSD, LPG 100 lbs and LPG 20 lbs, is as follows:

Explanation

International prices for oil and fuels have been continuously increasing since June 2023. Although the purchase price of Mogas 95 decreases nevertheless, the end-user tariff for Mogas 95 increases as a result of a strong increase in the correction of the surplus/deficit component. The end-user tariff for Gasoil LSD increases mainly as a result of a sharp increase in the purchase price, which is in line with Platts. To prevent a steep tariff fluctuation for Gasoil LSD at once, the increase of the purchase price will be implemented in two steps by means of a negative correction in the Surplus/Deficit component. However, this mitigating measure will have to be corrected in the coming months. LPG prices remain the same. The components 'Fuel Supply Guarantee' are adapted slightly after which the pre-financing by RdK and Curoil regarding the costs related to the use of the infrastructure on the refinery premises has ended completely.
