Explanation

The increase in the electricity tariffs is the result of an increase in the average fuel expenses for the production of electricity due to an increase in the fuel prices in combination with the expected production-mix and a higher correction factor over the month April 2024. Also the BOO-plant (CRU) contributes to the required production capacity which results in an increasing effect on the tariffs. The increase in the water tariffs is the result of an increase in the electricity expenses for the production of water in combination with a lower correction factor over the month April 2024.
