Explanation

The decrease of the electricity tariffs is the result of an increase in the average fuel expenses for the production of electricity due to an increase in the fuel price of Marine Gasoil (MGO) in combination with the expected production-mix and a lower correction factor over the month March 2024. Also the partial switch to Marine Fuel Oil (MFO) results in a decrease of the fuel costs as from March 2024. The decrease in the water tariffs is the result of an increase in the electricity expenses for the production of water in combination with a lower correction factor over the month March 2024.
