Explanation

The decrease of the electricity tariffs is the result of a decrease in the average fuel expenses for the production of electricity in combination with the expected production-mix and a lower correction factor regarding August 2024. The increase in the water tariffs is the result of an increase in the electricity expenses for the production of water in combination with a much higher correction factor regarding August 2024.
