## **Explanation**

There is a minor decrease in the average fuel costs for electricity production combined with an increase in the correction factor regarding July 2025. In addition to this, a correction component will be part of the base rate for electricity, jointly resulting in a slight increase in the electricity tariffs. The decrease in the water tariffs is the result of lower electricity costs for the production of water and a slightly higher correction factor regarding July 2025.
